A General Body meeting of AMMA-India was called on January 19, 2013 at 5.30 PM. The following were agenda items:

- a) Agenda Items were taken one by one. President thanked the members for attending the meet in large numbers and also from different parts of the country. Also thanked the members for their full support and cooperation in organizing this meet. Such supports are required in future also.
- b) Dr. Surendra Singh gave the details of membership of AMMA-India as on 19.1.2013 as below:

- c) Sh. S V Raju, Treasurer AMMA-India presented the financial status of the association which is not encouraging. The matter was discussed in the house and after long deliberations house agreed to adopt the following;
- Each member has to pay Rs.1000/- per year to the AMMA-India.
 - This payment has to be made every year in the month of April.

- The state chapter has to collect this payment from its members and transfer to AMMA-India national body or members can also send directly to headquarter by cheque/DD in the favour of AMMA-India payable at Pune.

Members also felt that audited account should be circulated to the members from next meeting onward. House also requested Executive Committee to appoint Chartered Accountant at the earliest and get the auditing done.

- d) Dr. Surendra Singh, Technical Advisor (AMMA-India) was requested to announce the new executive. Accordingly he announced the new executive following the association's by laws. The list of new executive is given in Annexure I. For filling the vacant position of Treasurer, a roaster of state members with numbers in decreasing order was prepared as below:

The Gujarat chapter has highest members so the post of treasurer was filled from Gujarat chapter. Gujarat Chapter proposed the name of Sh. Surendra S. Panchal, Bhagvati Krishi Udhog, Ahmadabad. While preparing the next roaster after three years, Gujarat chapter will not be considered and so on. This way all chapters would be represented in the national executive. After the end of first roaster a new roaster would be prepared where all the chapter members will be part of list. If any new state chapter becomes operational, the chapter will be added as per roaster.

The house also agreed to create a post of Chairman, International Activities and appointed past president Er. Baldev Singh against this post for three years. After three years this post will go to next past president and so on.

- e) The house also discussed the holding of next TAMM. It was decided that that next TAMM may be organized at Lucknow. UP chapter along with its pattern Dr. P R Singh, Head, Division of Agricultural Engineering, Indian Institute of Sugarcane Research, Lucknow who was present in the meeting agreed to the proposal. The next meet would be now at IISR Lucknow during the month of February 2014. Dates would be decided in consultation with institute.

The new Executive took charge from outgoing executive. The house congratulated the new executive and thanked the outgoing executive for their full support and cooperation. New president Mr. D S Balachandra Babu thanked the house and also the outgoing executive. The house also honoured Er. Baldev Singh, outgoing president for taking the association to new heights.
